### **LEGISLATIVE UPDATE**

LB721 to establish a license for surgical assistants in Nebraska passed final reading in the legislature on April 13<sup>th</sup> with a vote of 48-0-1. The bill was signed into law by Governor Pete Ricketts on April 19th and will become effective 90 days following passage. Following the effective date of the law, surgical assistants seeking to become licensed must demonstrate graduation from an accredited surgical assisting program, passage of the national surgical assistant certifying exam and current certification as a surgical assistant by a nationally recognized certifying body. A grandfather clause was included in the bill that expires on January 1st, 2017. Those surgical assistants wishing to become licensed under the grandfather clause must submit documentation of one of the following: (a) evidence satisfactory to the board that he or she has been functioning as a surgical first assistant as his or her primary function in a licensed health care facility within the last five years prior to September 1, 2016; (b) evidence of holding a current certification as a surgical first assistant issued by an approved certifying body; or (c) evidence of holding a credential as a surgical first assistant issued by another state or territory of the United States or the District of Columbia which has standards substantially equivalent to those of this state.

LB1061 that was introduced by Senator Kolterman to establish a registry for surgical technologists in

Nebraska did not advance out of committee this session. The final amendment of the bill was supported by the Nebraska Medical Association, the Nebraska Hospital Association, and the Department of Health and Human Services. The amendment included language to update the ruling from the 1898 case, Howard Paul vs. the State of Nebraska that will allow delegation to surgical technologists by surgeons and prevent the potential for a cease and desist order to be issued similar to the one that was issued for surgical assistants in the state. The bill continues to be unsupported by the Nebraska Nursing Association and AORN due to oversight by the Board of Medicine in Surgery instead of the Board of Nursing. The Ambulatory Surgery Center Association continues to oppose as well related to the competency assessment that has been included in place of the educational requirement. A new bill will be introduced by Senator Kolterman at the beginning of the 2017 legislative session to include the language that is supported by the NMA, NHA and DHHS.
